- The Government of Nepal [GoN] has allocated funds towards the cost of Constuction of Blacktop Road with RCC Drain Salokhari-Sitapur Bazar-Pathalgadha Khola Main Road and intends to apply part of the funds to cover eligible payments under the Contract for Constuction of Blacktop Road with RCC Drain Salokhari-Sitapur Bazar-Pathalgadha Khola Main Road (Contract No: LPRM/WORKS/NCB/09/078/079). Bidding is open to all eligible bidders as per Section V of Bidding Document
- 2. Laxmipur Patari Rural Municipality invites electronic bids from eligible bidders for the construction of Blacktop Road with RCC Drain Salokhari-Sitapur Bazar-Pathalgadha Khola under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- A. Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 5,30,00,000.00
- B. Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, at least 1 Contracts within the last ten (10) years, each with a value of at least NRs 5,65,00,000.00 that have been successfully or are substantially completed and that are similar to the proposed works
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Laxmipur Patari Rural Municipality, Maheshpur Patari, Laxmipur Patari, Siraha, Province Two, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Laxmipur Patari Rural Municipality, Maheshpur Patari, Laxmipur Patari, Siraha, Province Two, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 5000.0 NRs. till 24-04-2022 11:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 24-04-2022 14:00 hours at the office of Laxmipur Patari Rural Municipality, Maheshpur Patari, Siraha Province-2, Nepal

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 20,35,000.00 which shall be valid for 30 days beyond the validity period of the bid.
